Mr. Adams recalled that, at the last meeting, SOLitude Lake Management proposals to clean out Drainage Area 1, in a not-to exceed amount of \$2,000, and to remove eight dead pine trees in Drainage Area 1, in a not-to-exceed amount of \$2,720, were approved. SOLitude was unable to complete the work without employing subcontractors so the best price they could offer was \$2,600. In subsequent discussions, Staff decided it would be beneficial to wait until the winter for a better result and better pricing.
